Staples agree as follows:**1. COPYRIGHT LICENSE.** Buyer authorizes and licenses to Staples and authorized
users to reproduce Buyer's copyrighted and/or trademark protected materials
provided by Buyer or Buyer's authorized representatives at Staples Copy & Print
Stores during the term of this Agreement.**2. CONFIDENTIALITY.** Buyer understands that Staples is concerned about privacy
matters for its customers. To learn more about how we protect customer
information, please review our Privacy Statement, located at staples.ca. Staples will
follow its Privacy Policy, as the same may change from time to time.**3. AUTHORIZED REPRESENTATIVES.** Unless otherwise specified in writing by
Buyer, Buyer acknowledges that all of its employees are Buyer's authorized
representatives with respect to purchasing services or products from Staples
Copy & Print in connection with this Program. Authorized representatives of Buyer
must actively identify themselves as participants in the Program under this Agreement

including attorney's fees, for any breach of the above representation or warranty.**5. TERMINATION.** By execution of this Agreement, Buyer agrees to be bound by
